The CSocD: Advancing Social Progress for Over 75 Years

- Established in 1946, a key UN body dedicated to **inclusive social development**.
- Since 1995, the primary body advancing the **Copenhagen Declaration** and Programme of Action.
- Advises the Economic and Social Council (ECOSOC) on social policies and undertakes research on crucial social and economic issues.
- Three core focus areas: **Poverty eradication, full and productive employment and social integration**
- Supports the **2030 Agenda and its 17 SDGs** by accelerating progress toward reducing poverty and inequality.

The CSocD: Advancing Social Progress for Over 75 Years

- Offers a platform within the UN for global stakeholder to discuss **well-being** and **emerging social issues**.
- Spotlights critical topics: Poverty eradication, inequality, employment, **social protection**, and **digital inclusion**. Addresses **homelessness** for the first time at the UN.
- Shares innovative solutions to improve the lives of the most vulnerable such as **older persons**, **young people**, **indigenous peoples** and **persons with disabilities**.
- Connects **diverse stakeholders** to network across sectors and groups.
- Proposes policy recommendations to build inclusive societies where **everyone is included**.

CSocD63 Priority Theme

The CSocD63 will focus on “Strengthening **solidarity, social inclusion** and **social cohesion** to accelerate the delivery of the commitments of the Copenhagen Declaration on Social Development and Programme of Action of the **World Summit for Social Development** as well as the implementation of the 2030 Agenda for Sustainable Development”.

Global Challenges

EVERYONE INCLUDED

- Despite progress, extreme poverty remains high, with **692 million people** affected globally in 2024, while **733 million people** faced hunger in 2023.
- **Income and wealth inequality** are rising in many countries, contributing to social divides and mistrust in institutions.
- **Climate change, pollution, and biodiversity** loss threaten our planet and humanity.
- Escalating conflicts have displaced **68.3 million people**, destabilizing societies.
- Health inequities persist, leaving **60% of the world** without sufficient healthcare.
- Digitalization is **widening skills gaps, displacing workers**, and leaving older populations behind.
- **Aging populations** are straining healthcare and social security systems.
- Declining **trust in governments** and rising **discrimination** threaten social progress.
- Interconnected crises, from **financial downturns to pandemics**, are hitting vulnerable groups hardest.





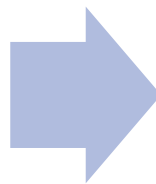

- ❖ Combat misinformation and disinformation to maintain a healthy information environment that fosters trust and social cohesion.

Multi-stakeholder Forum on the priority theme: Sharing Solutions

- ❖ Drive inclusive growth by prioritizing people over profit and empowering marginalized communities through **cooperatives and the social and solidarity economy (SSE)**.
- ❖ Demonstrate the global impact of SSE, with 3 million cooperatives employing 10% of the workforce.
- ❖ Support the SDGs and the Copenhagen Declaration by fostering social cohesion, solidarity, and sustainable development through SSE.
- ❖ Establish strong legal frameworks and policies to ensure the growth and integration of SSE into national economies.
- ❖ Leverage the International Year of Cooperatives 2025 as an opportunity to advance policy action and global recognition of cooperatives.
- ❖ Strengthen SSE's role in inclusive development through education, research, and policy engagement.

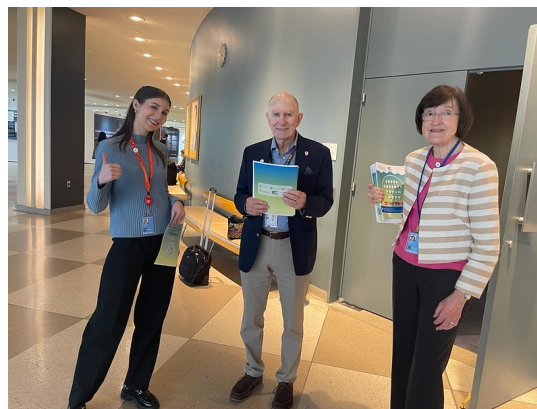


CSocD63 Expected Outcome

- ❖ **Priority Theme Resolution:** A resolution on the priority theme for CSocD64, titled “**Advancing coordinated and equitable policies for inclusive societies**”
- ❖ **Future Organization and Methods of Work of the Commission:** A resolution that will outline how the Commission will function and organize its work in future sessions.
- ❖ **Modalities for the Fifth Review and Appraisal of MIPAA** (Madrid International Plan of Action on Ageing): A resolution to set the modalities for reviewing and appraising the implementation of MIPAA.
- ❖ **Social Dimensions of NEPAD** (New Partnership for Africa’s Development): A resolution updating the social aspects of NEPAD, though delayed due to late issuance of the Secretary-General’s report.
- ❖ **Policies and Programmes Involving Youth:** A resolution related to youth policies and programs.

CSocD63 Side Events

- CSocD63 will host more than **50 side events**, covering a range of relevant topics. All NGOs are invited to participate.

Second World Summit for Social Development 2025

- The Summit is a historic opportunity to renew **global commitments made in Copenhagen in 1995**, rethink policies, and rebuild trust in societies.
- The commitment to **eradicating poverty, ensuring full and productive employment, and promoting social inclusion** remains as urgent as ever.
- To achieve this, we must **forge a new global consensus for inclusive social development** that leaves no one behind.
- The Summit will serve as a platform to mobilize political will and international cooperation, driving greater **social investments in quality education, healthcare, housing, social protection, and digital transformation**.



The Road from Copenhagen to Doha: Towards an Inclusive World

As we approach the Second World Social Summit from 4 to 6 November 2025 in Qatar, we have a unique opportunity **to reshape global social policies** and **reaffirm the principles of the Copenhagen Declaration**.

The path forward requires **changing mindsets, strengthening solidarity and trust**, and **investing in social inclusion and resilience**.



Civil Society: Driving Impact at CSocD63 & WSSD2

- ❖ CSOs amplify marginalized voices, advocate for inclusive SOCIAL policies, and ensure accountability.
- ❖ Engage in UN processes via statements, side events, and civil society forums.
- ❖ Influence decision-makers through lobbying, coalition-building, and social media.
- ❖ Bridge grassroots concerns with global policymaking for real-world impact.
- ❖ Provide research-based policy recommendations and deliver essential services (education, healthcare, aid) to underserved communities.
- ❖ Empower individuals and organizations through capacity building initiatives.
- ❖ Mobilize resources and advocate for emergency policies during crises.
- ❖ Ensure commitments lead to action, fostering partnerships and accountability.



The Way Forward: Towards an Inclusive World

- ❖ **Changing Mindsets:** Foster inclusive thinking by embracing diversity, promoting equality, dialogue, and shared responsibility.
- ❖ **Investing in People:** Guarantee access to education, healthcare, digital technologies and affordable housing for everyone.
- ❖ **Inclusive Societies:** Reduce inequality through progressive taxation, anti-discrimination laws, and social policies.
- ❖ **Universal Social Protection:** Ensure income security, healthcare, and employment support for all.
- ❖ **Decent Work:** Create fair jobs, formalize informal work, and prepare for green and digital economies.
- ❖ **Stronger Governance and Trust** - Promote transparency, participation, and accountable decision-making.
- ❖ **Global Solidarity and Cooperation** – Strengthen multilateral action for financing, debt relief, and social development.
